Upon review, we have recently changed our baseline year from 2018 to 2022 due to it being 5yrs since our original baseline and passing £35m turnover – 2022 is also a more accurate representation of our current business model with more contracts won. We will use this to set future targets and goal working from our estimated energy usage against our actual energy usage to identify where changes and savings can be made. In our Business & Energy Management System (BEMS) manual we have defined our significant energy usage and actions plans for reductions.

We review our Energy KPI's during quarterly management meetings and implement changes where required to support the delivery of our BEMS.

We will realize our Continual Energy Improvement program goals and objectives by ensuring that all members of the organization support and participate in the implementation of this policy.

Smith & Byford have communicated this Policy (ways of communication are detailed in our BEMS) and subsequent procedures to all company personnel, who will assist to ensure that our legal and moral obligations are met. This Policy will be reviewed on an annual basis and updated where necessary by the Board of Directors and is subject to an internal audit.
